- Nothing in this Agreement creates a joint venture, partnership, or employment relationship.
- The Affiliate has no authority to bind or represent Gistflash Media without written consent.

## 3. AFFILIATE RESPONSIBILITIES

The Affiliate agrees to:

- Promote Gistflash Media in an ethical, professional, and lawful manner
- Use only approved marketing materials and brand representations
- Provide accurate information to prospective clients and leads
- Avoid false, misleading, or exaggerated claims
- Comply with all applicable advertising, data protection, and real estate laws



## 4. PROHIBITED ACTIVITIES

The Affiliate shall NOT:

- Misrepresent Gistflash Media's services or pricing
  - Engage in spam, deceptive advertising, or illegal promotions
  - Use the Company's name or logo without authorization
  - Collect client payments on behalf of Gistflash Media unless expressly approved

## 5. COMMISSION & COMPENSATION

- The Affiliate shall earn commission of **5%** for **successfully completed transactions** generated through their efforts.
  - Commissions are payable only after confirmation of successful service delivery or transaction completion.
  - Gistflash Media reserves the right to withhold commissions for fraudulent or invalid referrals.

## 6. PAYMENT TERMS

- Payments shall be made via agreed payment channels.
  - Minimum payout thresholds may apply.
  - The Affiliate is responsible for all applicable taxes on earned commissions.

## 7. INTELLECTUAL PROPERTY

- All trademarks, logos, content, and materials remain the exclusive property of Gistflash Media.
  - Limited and non-transferable permission is granted solely for promotional purposes under this Agreement.

## 8. CONFIDENTIALITY

The Affiliate agrees to keep confidential all non-public information, including:

- Client data
  - Pricing structures
  - Marketing strategies
- this obligation survives termination of this Agreement.

- This Agreement begins upon acceptance and continues until terminated.
  - Either party may terminate the Agreement at any time with or without notice.
  - Upon termination, the Affiliate must cease using all Company materials immediately.
